



Off-licence

Sections 18, 19, 59 and 64, Sale and Supply of Alcohol Act 2012

67/OFF/32/2019

Pursuant to the Sale and Supply of Alcohol Act 2012, **Shaky Bridge Wines Limited** is authorised to sell or deliver alcohol from the premises situated at Rapid 65 Graveyard Gully Rd, Alexandra and known as Shaky Bridge Wines, to any person for consumption off the premises.

As this licence is endorsed under section 40 of the Act, the licensee is entitled to sell alcohol from **(but not on)** the premises and deliver it to somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

- (a) The remote sale of alcohol may be made at any time on any day.
- (b) No alcohol is to be delivered on Good Friday, Christmas Day or before 1.00pm on Anzac Day.
- (c) No alcohol is to be delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made:
 - i. On the premises; or
 - ii. From grapes or fruit harvested from land on which the premises are situated.
- (d) Alcohol may only be delivered Monday to Sunday between the hours of 6.00am and 11.00pm.
- (e) Order forms for mail or internet orders must require the buyer and the prospective receiver to declare that they are 18 years of age or over.
- (f) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- Until the close of the period for which it is renewed; or
- If an application for the renewal of the licence is duly made before the licence would otherwise expire until the close of the period 3 years after the period for which it was last renewed.

Expiry date being **21 August 2022** unless renewed for a further period.
